

NON-EXCLUSIVE COPYRIGHT LICENSE

This Agreement ("Agreement") is entered into by and between _____
[Author's Full Name] ("Owner") and the **International Foundation of Fashion Technology Institutes (IFFTI)**, with its principal place of business at New Delhi, India.

A. The International Foundation of Fashion Technology Institutes (IFFTI) is supporting the 2026 IFFTI Conference, which will be organized and hosted by a designated host institution in Ho Chi Minh City, Vietnam, from 13th to 17th April 2026. IFFTI provides academic guidance, coordination, and global branding for the Conference, while the host institution administers and manages all academic and logistical operations and on-ground execution.

B. The Owner holds the copyright to certain materials relating to submitting a paper for presentation at the 2026 IFFTI Conference and is willing to grant IFFTI and the host institution the rights to use said materials under the terms outlined below.

AGREEMENT TERMS

1. Effective Date

This Agreement shall be effective as of the date of signing by the Owner.

2. License Grant

The Owner hereby grants IFFTI and the host institution a non-exclusive, royalty-free license to copy, display, and distribute the materials described in Appendix A (the "Material"), in whole or in part, for use in:

- Conference Proceedings (digital or print),
- Academic archiving on IFFTI and host institution platforms,
- Promotional use related to the 2026 IFFTI Conference.

3. Ownership of Rights

All rights, title, and interest in the original Material, including copyright, remain with the Owner.

4. Use of Derivative Works

IFFTI and the host institution may develop derivative works for internal, academic, and conference-related use, but the copyright of any such derivatives will remain with the Owner.

5. Termination

This Agreement may be terminated by the written agreement of both parties. If either party shall be in default of its material obligations under this Agreement and shall fail

to remedy such default within sixty (60) days after receipt of written notice thereof, this Agreement shall terminate upon expiration of the sixty (60) day period.

6. Entire Agreement

This document represents the entire agreement between the parties. Any prior agreements, discussions, or understandings are superseded by this document.

7. Governing Law

This Agreement shall be governed by and construed under the laws of New Delhi, India.

8. Originality and Exclusivity of Submission

The Owner confirms that the material submitted is original and has not been previously published, nor is it under consideration for publication elsewhere. It is understood that **submission of the same or substantially similar work to another publication outlet is not acceptable**, as per academic publishing standards and ethical guidelines. This ensures the integrity of the IFFTI Conference proceedings and respects the rights of other editors and publishers.

9. Electronic Signatures

This Agreement may be executed electronically, and signatures transmitted via scanned copy, email, or electronic signature platform (such as Adobe Sign, etc) shall be deemed as valid and binding as original signatures.

Note: The host institution is responsible for logistical coordination of the 2026 IFFTI Conference, but is not a party to this legal agreement.
